INDEPENDENT AUDITOR'S REPORT To the Members of Great Lakes Institute of Management

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Great Lakes Institute of Management ("the Company"), which comprise the Balance Sheet as at 31st March 2020, and the Statement of Income and Expenditure, and Statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2020, and its excess of income over expenditure and its cash flows for the year ended on that date.

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Companies Act, 2013. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements



that are relevant to our audit of the financial statements under the provisions of the Companies Act, 2013 and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

The Company's Board of Directors is responsible for the matters stated in section 134(5) of the Companies Act, 2013 ("the Act") with respect to the preparation of these financial statements that give a true and fair view of the financial position, financial performance, and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the accounting Standards specified under section 133 of the Act. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Board of Directors is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

Those Board of Directors are also responsible for overseeing the company's financial reporting process.

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.




Inherent Limitations of Internal Financial Controls Over Financial Reporting

Note 19- SIGNIFICANT ACCOUNTING POLICIES AND NOTES FORMING PART OF FINANCIAL STATEMENTS FOR THE YEAR ENDED MARCH 31, 2020.

19.1 SIGNIFICANT ACCOUNTING POLICIES

1. Accounting Convention:

The financial statements are prepared on accrual basis under the historical cost convention and on the basis of going concern. These statements are in compliance materially with applicable Accounting Standards and statutory provisions.

2. Grants and Contributions:

Revenue grants and donations other than corpus donation and contribution towards specific funds received are considered as income for the year. Corpus and other contributions received for specific purposes are directly accounted under the respective funds.

3. Borrowing Costs:

Borrowing costs that are attributable to the acquisition or construction of qualifying assets are capitalized as part of the cost of such assets, in accordance with the provisions of Accounting Standard (AS) 16 issued by Institute of Chartered Accountants of India (ICAI). Other borrowing costs are recognized in the Income and Expenditure Account in the period in which they are incurred.

4. Fixed Assets & Capital Work in Progress

- a. Fixed assets are recorded at cost of acquisition including significant incidental costs and installation costs. Capital Work in Progress includes advances paid to acquire the assets and cost of assets not ready for intended use before the Balance Sheet date. Expenses on Course and Curriculum development are written off in the year in which it is incurred.

5. Depreciation:

- Fixed assets are depreciated under Written down Value method at the rates prescribed under Schedule II of Companies Act 2013. Proportionate depreciation is provided in the year of addition/disposal.
- Expenses incurred on software and course wares are amortized over a period of five years.
- Leasehold charges on land are amortized over the period of Lease.
- In case assets becoming obsolete, depreciation is provided in full for the balance written down value.

6. Leased Assets

Leases where the lessor effectively retains all the risks and benefits of ownership of the leased assets are classified as operating lease. Operating lease payments are recognized as an expense in the Income & Expenditure Account as per the lease term.

7. Revenue recognition:

Revenues are recognized proportionate to the duration of the courses falling within the period covered by financial statements and are net of provisions for direct obligations.

8. Employee benefits:

A. GRATUITY.

In accordance with the provisions of the Payment of Gratuity Act, 1972 the Company provides for gratuity, a defined benefit retirement plan (Gratuity Plan), to all eligible employees. The Gratuity Plan provides a lump sum payment to vested employees at time of retirement, death, in capacitation or termination of employment, of an amount based on the respective employee's salary and tenure of service with the company. Liability with regard to the Gratuity Plan is determined by actuarial valuation at each balance sheet date using projected unit credit method.

The Company fully contributes all ascertained liabilities to the Great Lakes Institute of Management Employees Group Gratuity Trust (Trust). The Trustees administer the contribution made to the Trust and invest in a scheme with Kotak Mahindra Old Mutual Life Insurance Ltd. The premium paid is charged off in the Income and Expenditure Account as expense. The Company recognizes the net obligation of the Gratuity Plan in financial statements as indicated by the said fund as on the date of financial statements. Actuarial gains and losses are recognized in the respective year's Income & Expenditure account.

B. PROVIDENT FUND

Contributions to Provident fund for eligible employees are made in accordance with the provisions of Employees Provident Fund and Miscellaneous Provisions Act 1952.

C. COMPENSATED ABSENCES

The Company does not have a policy of accumulation of leave. Leave benefits accruing in the calendar year are to be encashed within six months.

D. Bonus

A minimum payment of Bonus is paid to eligible employees.

9. Foreign Exchange Transactions:

Transactions in foreign exchange are recorded at the rates prevailing on the date of the transaction. Liabilities in foreign currency, outstanding at year end are translated at year end rates and the exchange rate difference is (a) adjusted to the cost of fixed assets if the same relates to acquisition of fixed assets and (b) recognized in Income and Expenditure account in other cases.




