Objectives:

7. To render financial aid to deserving alumni in cases of extreme compassionate circumstances.
8. To bring out magazines, souvenirs and newsletters highlighting the activities of the Institute and its Alumni.
9. To organize cultural and educational programs, and also to conduct Alumni Day celebrations every year.
10. To help the alumni to get advice from the Institute on various technical problems and job opportunities that they may come across in their work and real life.
11. To raise funds for various corporate social responsibility activities through which public at large can be benefited.
12. To carry out such other activities as may be necessary for furthering above aims and objectives.
